Dear Parent or Guardian:

The JJC wishes to explain our policy regarding resident visitation. What follows is information regarding all aspects of in-person visitation and TEAMS virtual visits with the intention that the process is as smooth and enjoyable an experience as possible for all involved. If you have additional questions or concerns, please contact the JJC at (630) 406-7480.

**Times and Scheduling:**

1. In-person visitation will occur three times weekly; residents are allowed one (1) hour in-person, non-contact visit on Sunday, Tuesday and Thursday each calendar week.
2. There are four (4) visiting sessions on Sundays and Thursdays, and two (2) visiting sessions on Tuesdays. Each session is one (1) hour in length with a fifteen (15) minute break in between periods to allow for visitor and resident transition.

**Note: No visitors will be allowed into the facility for visitation after 3:15 p.m. on Sunday or after 8:45 p.m. on Thursday.**

3. TEAMS virtual visitation will occur three times weekly; residents are allowed one (1) fifteen (15) minute TEAMS visit on Monday, Wednesday and Saturday each calendar week.

4. Level 1 and Level 2 residents are allowed to visit with only parents/guardians and biological children.

5. Level 3 residents are permitted to visit with parents/guardians, biological children, and approved extended family members (i.e., grandparents, great-grandparents, siblings, aunts/uncles).
6. The JJC requests that visitors make appointments prior to the visitation times. The phone number **to schedule a visitation time is (630) 406-7480**. Appointments can be made any time of the day or night.
7. Only visitors who are currently in visitation and those who are scheduled for the next visitation time slot will be allowed in the building. All other visitors must wait outside of the building. **Children must be supervised by an adult while in the facility's lobby; JJC and court security staff are not permitted to supervise visiting children.**
8. All visitors will be required to sign a visitation log prior to visiting a resident.
9. Visits shall be supervised to the extent that privacy is assured.
10. Visitors are subject to search, as provided by law.

### **Visitation Screening:**

**Note: No packages, purses or electronic devices are permitted in the facility.**

1. All visitors are required to have a valid photo identification card.
2. All visitors are required to pass through a metal detector, which is monitored by security personnel. Anyone who activates the metal detector will be required to remove personal property until they no longer activate it.

**Note: Visitors shall leave jewelry and other metal objects at home or locked in their vehicle. Security personnel must approve all visitors past the metal detector.**

3. All visitors are also required to pass through a millimeter wave (non-radiation) body scanner. Exceptions will be made for known pregnant visitors, children under 4'3" and those visitors identified as being unable to stand or pass through the scanner properly. Visitors who are unable to pass through the body scanner will only be eligible for **non-contact visitation** with residents.
4. All coats and hats must be secured in a locker located in the JJC lobby.
5. Visitors are not allowed to bring in any food or beverages; however, they may purchase these items for residents from the vending machines located in the JJC's lobby.
6. Hygiene products are provided for residents by the JJC. They will not be accepted from visitors.
7. No money will be accepted for residents.
8. No written correspondence will be allowed to pass through visitation. All mail must be sent through the U.S. Postal Service.
9. There is no smoking, vaping or drinking alcohol allowed in the JJC.
10. If visitors leave the facility for any reason, the visit will be terminated.
11. Visitors who appear to be, or are suspected of, being under the influence of alcohol OR a controlled substance will be denied visitation with residents.
12. Visitors are not permitted to wear gang colors or represent gangs in any way.
13. Staff or security personnel may terminate a visit at any time for disruptive behavior, failure to follow staff directions or any other reasonable cause.

### **Approved Visitors:**

1. Two (2) visitors will be allowed to visit at a time to include: parent/legal guardian (must have current proof of guardianship), biological children and/or court-approved visitors.
2. If there are multiple visitors, the time will be divided by that number, or as determined by the resident.
3. Step-parents may visit only if they are currently married to the resident's parent; live-in paramours are permitted to visit as long as they are accompanied by the parent.
4. Biological parents are permitted to visit unless court ordered otherwise.
5. When children of any age are visiting, they must be accompanied by a parent/guardian.
