MEET ASSISTANT SUPERINTENDENT AMY SIERRA

Amy Sierra has over 26 years of experience at the Juvenile Justice Center. She started her career as a Youth Counselor in 1991 at the former Kane County Youth Home in Batavia, IL. She was certified by the National Institute of Corrections in Gender-Responsive Programming Development and she has also conducted extensive training in Sexual Misconduct and Staff Boundaries issues. Amy was promoted to her current position of Assistant Superintendent in 2010, and began to transition the JJC's programming and services to be aligned with evidence-based practices. She also began to lay the foundation for the JJC's compliance with the federal Prison Rape Elimination Act (PREA) in 2013. Amy is a previous recipient of the National Partnership for Juvenile Services (NPJS) Bob Rader Detention Services Worker of the Year Award and the Community Crisis Center Partners in Peace Award.

A NOTE FROM THE SUPERINTENDENT

Although the Andy Williams song says, "It's the most wonderful time of the year", the truth is the holidays can be tough for anyone. This is especially true of young people who are detained and away from their families. So rather than acting as if holidays don't exist in juvenile detention, we did our best to give the kids a Happy Thanksgiving and Merry Christmas. All the while, setting the example of what it means to care about and have empathy for others. This includes our kitchen personnel preparing special meals, holiday decorating contests, extra visitation and providing residents with a small gift to open on Christmas morning. The residents were also encouraged to think about others and were provided with greeting cards they could give to staff or send to loved ones. With the help of our volunteers, staff, community and intergovernmental partners, the residents were treated to a Christmas Party which included food, games, cookie decorating and even a little caroling. Thanks to the support of the Regional Office of Education, to further promote the spirit of thinking of others during the holiday season, the residents had the opportunity to purchase small gifts for family members by using coupons they'd earned for positive behavior and achievement in school. Prior to the party, daily focus groups concentrated on etiquette while hosting an event, demonstrating pro-social behavior and showing appreciation to others. In 2018, we're going to continue to do our best to promote a positive environment and to assist our residents in developing the skills necessary to change thinking and positively influence decision making.

In June of 2017, the Kane County Juvenile Justice Center was visited by the JHA. Aside from praising the JJC's school program, the association commended the JJC for actively seeking out community partners to provide youth with diverse and meaningful programming. The advocacy group also

acknowledged the JJC for our commitment to transparency and understanding of the importance of accountability to the public.

CERAMICS

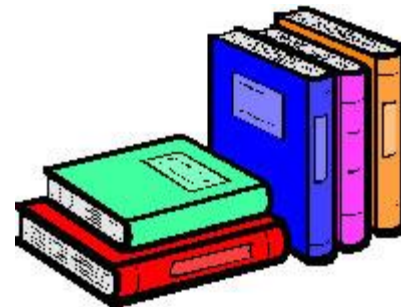
JJC Volunteer, John Lo, worked with the residents creating these beautiful ceramic dishes.

Dental Care

Smile Programs, the mobile dentists, is an "in-school" dental program designed to address today's dental care crisis and keep children healthy. Their innovative model offers state-of-the-art dental care. This program is easy and convenient, and is offered at no cost to parents* and no cost to the JJC.

Many children sadly find themselves without affordable access to dental care. The Smile Program uses the latest technology in portable equipment, bringing dental services directly to the JJC. They use their network of locally-licensed dentists, hygienists, and assistants to provide high quality care to our residents. Their program sets up a mini dental clinic directly in the JJC.

The residents will receive:

- Complete oral exam
- Cleaning
- Oral health education
- A Report Card from the dentist
- A free toothbrush

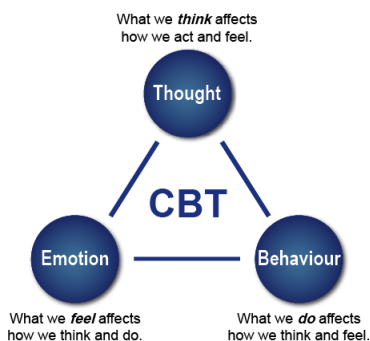
MEET IVARS SPALIS, JJC PRINCIPAL

Ivars has been the JJC School Program administrator since 2007 and officially became principal of the program in 2014. Before taking the helm as principal, Ivars was a classroom teacher at the JJC from 1999 until 2007. He earned his B.A. (Secondary Education/Language Arts) and teaching certification from Northeastern Illinois University in 1999. Ivars greatly enjoyed serving the students in his time as a classroom teacher and enthusiastically used innovative approaches to keep his lessons engaging. As an employee of the Kane County ROE under the leadership of late Assistant Superintendent Julie Vallejo, Ivars was encouraged to pursue his Master's Degree in Educational Leadership at Aurora University in order to become a school administrator. Ivars completed this program of study in 2007, enabling him to make a greater impact for the students at the JJC. As a member of the Kane County ROE's School Principals Network, Learning Leaders, and Teach to Lead team, Ivars continues to advocate for JJC students and networks with others to ensure JJC students receive the best possible education. He gives much credit to his growth as an educator to Shirley LeClere of the ROE who has served as his mentor. The support of Pat Dal Santo, Kane County ROE Superintendent, has been an integral part of the success of the JJC School Program. Ivars grew up in Rolling Meadows, Illinois, the son of Latvian immigrants who instilled in him the value of education. He speaks and reads Latvian fluently and has actively participated in Latvian-American organizations, including schools over the years.

CBT



On July 6, 2014, the JJC implemented the CBT program, which uses positive reinforcement through incentives such as a token economy, level-based privileges, and special events. In return, residents attend 300 minutes of school and engage in cognitive groups and exhibit pro-social behavior. They earn rewards for good behavior with commissary nights, Friday night movies with popcorn, and Saturday night Plus Parties. Also included in the program are community-based programs such as therapy dog, gender-specific groups, grief counseling, and community health organizations.

FEED MY STARVING CHILDREN

Founded in 1987, Feed My Starving Children (FMSC) is a Christian non-profit that provides nutritionally complete meals specifically formulated for malnourished children.

- To reinforce the notion that literacy development comes from any and all types of reading
- To activate and engage minds through book discussions

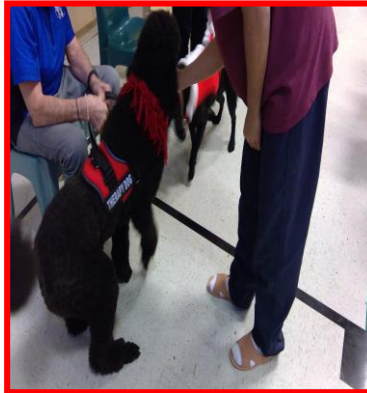
